APPROVE AN AMENDMENT TO RULE XI., INVESTMENT POLICY, OF THE RULES OF THE BOARD

May 14, 2010

WHEREAS, the Golden Gate Bridge, Highway and Transportation District's (District) investments are guided by the District's Investment Policy; and,

WHEREAS, it is a requirement that all District investments be made with the "prudent person" standard and conform to all pertinent laws of the State of California, in particular, California Government Code Section 53601 (Section 53601), which sets forth the investments public agencies in California are permitted to make; and,

WHEREAS, on February 27, 2009, the District Board of Directors approved an amendment to RULE XI., INVESTMENT POLICY, of the Rules of the Board; and,

WHEREAS, the Rules, Policy and Industrial Relations Committee recommends a further amendment to the Investment Policy to specifically authorize the investment of District funds in the State of California's Local Agency Investment Fund (LAIF) up to the maximum amount allowed by the State Treasurer, pursuant to Government Code Section 16429.1; now, therefore, be it

RESOLVED that the Board of Directors of the Golden Gate Bridge, Highway and Transportation District hereby approves an amendment to **RULE XI.**, **INVESTMENT POLICY**, of the *Rules of the Board* by adding Subsection "J", as follows:

"J. Local Agency Investment Fund

"The District is also authorized to invest in the State of California's Local Agency Investment Fund pursuant to *California Government Code Section 16429.1*, up to the maximum amount allowed by the State Treasurer."
