## AUTHORIZE EXECUTION OF AN AGREEMENT WITH MARIN COUNTY TRANSIT DISTRICT TO OPERATE THE MUIR WOODS SHUTTLE FOR THE SUMMER OF 2010

February 12, 2010

**WHEREAS**, the Marin County Transit District (Marin Transit) operated the Muir Woods Shuttle (Shuttle) in the summer of 2009; and,

**WHEREAS**, the Marin Transit received no responses to its Request for Proposals, issued in November 2009, seeking an operator for the Summer 2010 service; and,

**WHEREAS**, the Marin Transit sent a written request to the Golden Gate Bridge, Highway and Transportation District (District) on January 12, 2010, requesting that Golden Gate Transit operate the Shuttle during the Summer 2010 season; and,

**WHEREAS**, the Summer 2010 Shuttle will operate from Saturday, May 1, 2010, through Sunday, September 26, 2010, and the service will be identical to that operated in 2009; and,

WHEREAS, costs of the Summer 2010 Shuttle are estimated to be \$326,686.00, including operating costs, vehicle lease costs and marketing/promotion expenses; all of which will be paid by the Marin Transit; and,

**WHEREAS**, the Transportation Committee, at its meeting of February 11, 2010, has so recommended; now, therefore, be it

**RESOLVED** that the Board of Directors of the Golden Gate Bridge, Highway and Transportation District hereby authorizes execution of a one-year Agreement with the Marin County Transit District (Marin Transit) to operate the Muir Woods Shuttle from Saturday, May 1, 2010 through Sunday, September 26, 2010, with the understanding that the service will be paid for by Marin Transit at a cost not to exceed \$326,686.00.
