Sonoma*, that are in need of 24-volt battery system improvements for continued safe, uninterrupted passenger service; and,

WHEREAS, on April 13, 2010, the District advertised Contract No. 2010-FT-17, and a sole bid was received, opened and publicly read by the Secretary of the District by the deadline date of May 11, 2010; and,

WHEREAS, following review of the bid, staff determined that the sole bidder, Dahl-Beck Electric is responsive and responsible; and,

WHEREAS, the Disadvantaged Business Enterprise (DBE) Program Administrator determined that Dahl-Beck Electric has complied with the DBE requirements applicable to this Contract and, at this time, no DBE participation is anticipated during the performance of these services; and,

WHEREAS, the total project budget will be funded as follows: \$144,000.00 Federal Transit Administration funds and \$36,000.00 District Reserves; and,

WHEREAS, the Building and Operating Committee, at its meeting of May 27, 2010, has so recommended; now, therefore, be it

RESOLVED that the Board of Directors of the Golden Gate Bridge, Highway and Transportation District hereby authorizes award of Contract No. 2010-FT-17, *Battery System Improvements for Spaulding Ferries*, to Dahl-Beck Electric, Richmond, CA, in the amount of \$157,365.00, including all Category A items and select Category B items; and, be it further
