WHEREAS, the Board of Directors (Board), by Resolution No. 2009-038 at its meeting of April 24, 2009, authorized execution of a Professional Services Agreement with Marine Systems Corporation relative to Request for Proposals (RFP) No. 2009-FT-10, Engineering and Detailed Design Services for the Refurbishment of the M.V. Snohomish (M.V. Napa) and the M.V. Chinook (M.V. Golden Gate) Ferries; and,

WHEREAS, on December 18, 2009, the Board, by Resolution No. 2009-104 at its meeting of December 18, 2009, authorized execution of Amendment No. 1 to RFP No. 2009-FT-10 and approved an increase in the Project budget to \$635,000.00, to cover the expansion in the scope of work covered in the Amendment; and,

WHEREAS, the District issued Contract No. 2010-FT-1, *Refurbishment of the M.V. Napa and the M.V. Chinook Ferries*, and the Board, by Resolution No. 2010-026 at its meeting of March 26, 2010, awarded the contract to Ice Floe, LLC, dba Nichols Brothers Boat Builders (Nichols Brothers); and,

**WHEREAS**, initial meetings with Nichols Brothers indicated that some equipment will need to be replaced and Nichols Brothers advised the District to address these issues early in the project to avoid costly change orders; and,

WHEREAS, in order to facilitate the newly contemplated work by Nichols Brothers, additional design engineering work is required of Marine Systems Corporation (Marine) at the same hourly rates set forth in its original Agreement with Marine; and,

WHEREAS, the Building and Operating Committee, at its meeting of May 27, 2010, has so recommended; now, therefore, be it
