WHEREAS, the SFFT Restrooms Accessibility Modifications Project (Project) will improve the paid waiting areas and improve access to the paid waiting area restrooms; and,

**WHEREAS**, on April 6, 2010, the District advertised Contract No. 2010-FT-13 and ten bids were received, opened and publicly read by the Secretary of the District by the deadline date of May 11, 2010; and,

**WHEREAS**, following review of the bids, staff determined that the lowest bidder, Integra Construction Services, Inc. (Integra) is responsive and responsible; and,

WHEREAS, the Disadvantaged Business Enterprise (DBE) Program Administrator has determined that Integra Construction Services, Inc., has complied with the DBE requirements applicable to this Contract and that, at this time, a 24.8% DBE participation is anticipated during the performance of this Contract; and,

WHEREAS, the total Project will be funded as follows: \$60,986.00 FTA grant funds and \$171,314.00 Public Transportation Modernization, Improvement and Service Enhancement Account grant funds from the California State I-Bond program; and,

WHEREAS, the Building and Operating Committee, at its meeting of May 27, 2010 has so recommended; now, therefore, be it
