Recommendation

Summary

The Board and Standing Committee meeting schedule is subject to change throughout the year, and if a meeting is either cancelled or rescheduled, a public notice will be issued and appropriate notifications sent.

There is a minimal financial impact associated with the proposed 2022 meeting schedule.
