## **ORDINANCE NO. 2022-004**

## AN ORDINANCE TO AMEND THE MASTER ORDINANCE TO UPDATE PARKING FEES ON ADMINISTRATIVE HOLIDAYS

December 16, 2022

THIS ORDINANCE is adopted with reference to the following facts and circumstances which are found and declared by the Board of Directors (Board) of the Golden Gate Bridge, Highway and Transportation District (District):

- 1. On October 28, 2022, the Board approved an amendment to the Master Ordinance to standardize parking hours and eliminate seasonal variations.
- 2. In particular, the Board approved extending the public parking hours in the employee lot to include weekdays from 3:30 p.m. 9:00 p.m., setting the hours for public parking on Saturdays, Sundays, and District observed Administrative Holidays from 7:00 a.m. 9:00 p.m. for all of the areas made available for public parking at the Bridge, and increasing the public parking fee to an hourly rate of \$5, up to a maximum consecutive parking time of three (3) hours, for designated parking lots at the Golden Gate Bridge.
- 3. As part of the Board's action on October 28, 2022, the Board approved a revision to the Master Ordinance that inadvertently exempted parking fees at that Golden Gate Bridge on Administrative Holidays.
- 4. Staff recommends that the Board approve a further amendment to the 2022 Master Ordinance to remove the incorrect text and reflect the District's current practice of charging parking fees on District observed Administrative Holidays at the Bridge parking lots.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE GOLDEN GATE BRIDGE, HIGHWAY AND TRANSPORTATION DISTRICT AS FOLLOWS:

Section 1. Subsection I.3.a, "Parking Facilities at the Golden Gate Bridge," of Section I, "General Provisions," is amended as follows:

(a) Parking Facilities at the Golden Gate Bridge. The District may make available for public parking spaces in the District's employee parking lot and other parking areas around the Golden

Gate Bridge Toll Plaza Administration Building on Mondays through Fridays from 3:30 p.m.

to 9:00 p.m., and Saturdays, Sundays and District observed Administrative Holidays from 7:00

a.m. to 9:00 p.m. The District may also make available for public parking spaces in the

District's Toll Plaza East Parking Lot on Mondays through Sundays and District observed

Administrative Holidays from 7:00 a.m. to 9:00 p.m. Where such public parking spaces are

designated, no person, other than a Director or employee of the District, shall park or leave

standing any vehicle without immediately paying a parking fee of five dollars (\$5.00) for each

hour, with no proration for shorter periods, up to a maximum consecutive parking time of three

(3) hours. Fees shall be paid as directed by signage.

This provision does not apply to buses parked in areas designated for buses.

Parking fees apply on District observed Administrative Holidays (New Year's Day, Martin

Luther King Jr. Day, President's Day, Cesar Chavez Day, Memorial Day, Independence Day,

Labor Day, Veterans Day, Thanksgiving Day, Day after Thanksgiving and Christmas Day).

Section 2. The effective date of this Ordinance shall be upon completion of the installation of

the new parking machines and associated changes in signage and public outreach.

Section 3. If any provision of this ordinance or the application thereof to any person or

circumstances is held invalid, such invalidity shall not affect any other provisions or applications of

the Ordinance which can be given effect without the invalid provision or application, and to this end,

the provisions of this Ordinance are severable.
