AUTHORIZE A BUDGET TRANSFER WITHIN THE FY 12/13 FERRY TRANSIT DIVISION OPERATING BUDGET RELATIVE TO THE DRY-DOCKING OF THE M.V. GOLDEN GATE

March 8, 2013

WHEREAS, the Golden Gate Bridge, Highway and Transportation District's (District) dry-docking budget for FY 12/13 is based upon a routine, scheduled dry-docking for each of the following: the *M.V. Mendocino*, the *M.V. Del Norte* and the *M.V. Golden Gate*.; and,

WHEREAS, the refurbishment of the *M.V. Napa* is in the final stages of warranty support and documentation; and,

WHEREAS, problems and delays in awarding the *M.S. San Francisco* refurbishment contract resulted in the need to dry-dock it as well; and,

WHEREAS, the M.V. Golden Gate is presently scheduled to be dry-docked at a local shippard in the next several weeks and it is anticipated that this dry-docking will exceed the Ferry Transit Division's estimated budget, as the ferry recently experienced a failure of a waterjet hub seal; and,

WHEREAS, each of the District's ferryboats is required by U.S. Coast Guard Regulation to be dry-docked once every two years to provide the opportunity to inspect the underwater hull and appendages; and,

WHEREAS, a routine dry-docking is usually estimated at \$50,000.00 to \$100,000.00, and an emergency dry-docking can also be required should a vessel have a problem; and,

WHEREAS, the Finance-Auditing Committee, at its meeting of March 7, 2013, has so recommended; now, therefore, be it

RESOLVED that the Board of Directors of the Golden Gate Bridge, Highway and Transportation District hereby authorizes a budget transfer from the FY 12/13 Bridge Division Operating Budget to the FY 12/13 Ferry Transit Division Operating Budget, in the amount of \$150,000.00, for dry-docking of the *M.V. Golden Gate*.
