**APPROVE CHANGES TO THE TABLE OF ORGANIZATION
RELATIVE TO THE PLANNING DEPARTMENT**

WHEREAS, the needs of the Golden Gate Bridge, Highway and Transportation District (District) and the role and responsibilities of its Planning Department (Department) have changed and increased through the years, requiring the Department to adapt by making changes to its structure; and,

WHEREAS, to adequately respond to the increasing workload, the newly hired Deputy General Manager/Administration and Development, has evaluated the Department staffing levels and structure and developed a proposal to better reflect upcoming needs and broadened compliance requirements; and,

WHEREAS, implementation of the recommended changes will effect a more streamlined and operationally efficient Department structure within the present budget constraints and with the least operational disruption while drawing on the knowledge, experience, skills and talents of the current Department staff; and,

WHEREAS, the Rules, Policy and Industrial Relations Committee/Committee of the Whole, at its meeting of October 12, 2012, has so recommended; now, therefore, be it

RESOLVED that the Board of Directors of the Golden Gate Bridge, Highway and Transportation District (Board) hereby approves changes to the Table of Organization relative to the Planning Department, as follows:

1. Position Addition
 - a. One Principal Planner position, with an annual salary range of \$95,452.00 to \$115,342.00.
2. Position Deletions
 - a. One Access and Compliance Planner position, with an annual salary range of \$78,702.00 to \$95,140.00, and
 - b. One Senior Planner position, with an annual salary range of \$74,217.00 to \$89,700.00; and, be it further

RESOLVED that the Board hereby approves the above-stated Planning Department changes in the Administration and Development Division, with the understanding that fringe benefit costs are not included in the salary ranges stated above for the position addition and the position deletions; and, be it further

RESOLVED that the Board hereby approves the above-stated Planning Department changes in the Administration and Development Division to the District's Table of Organization; and, be it further

RESOLVED that the costs associated with the above-stated Planning Department changes in the Administration and Development Division will result in savings to the FY 12/13 District Division Operating Budget/Planning Department, in the approximate amount of \$69,498.00.

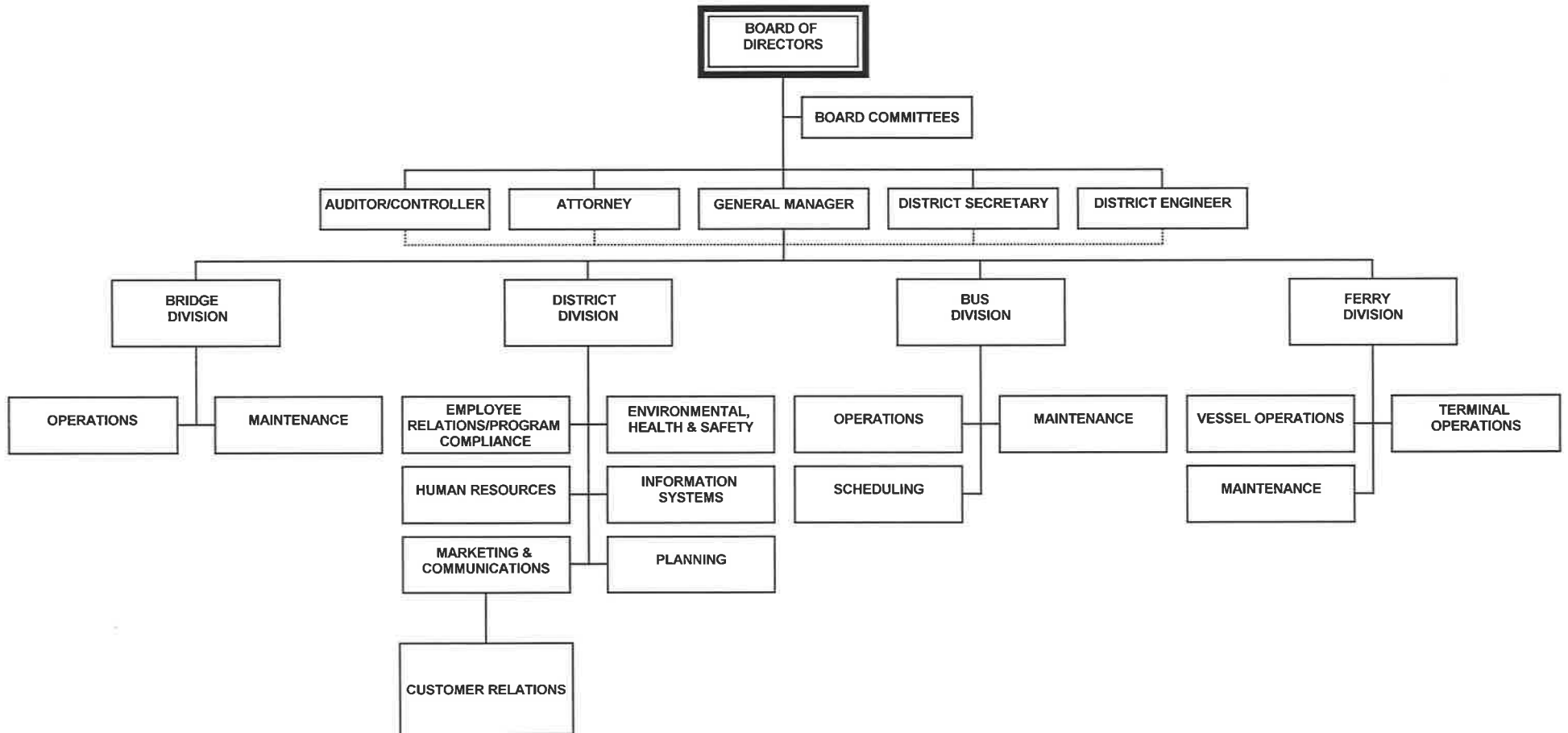

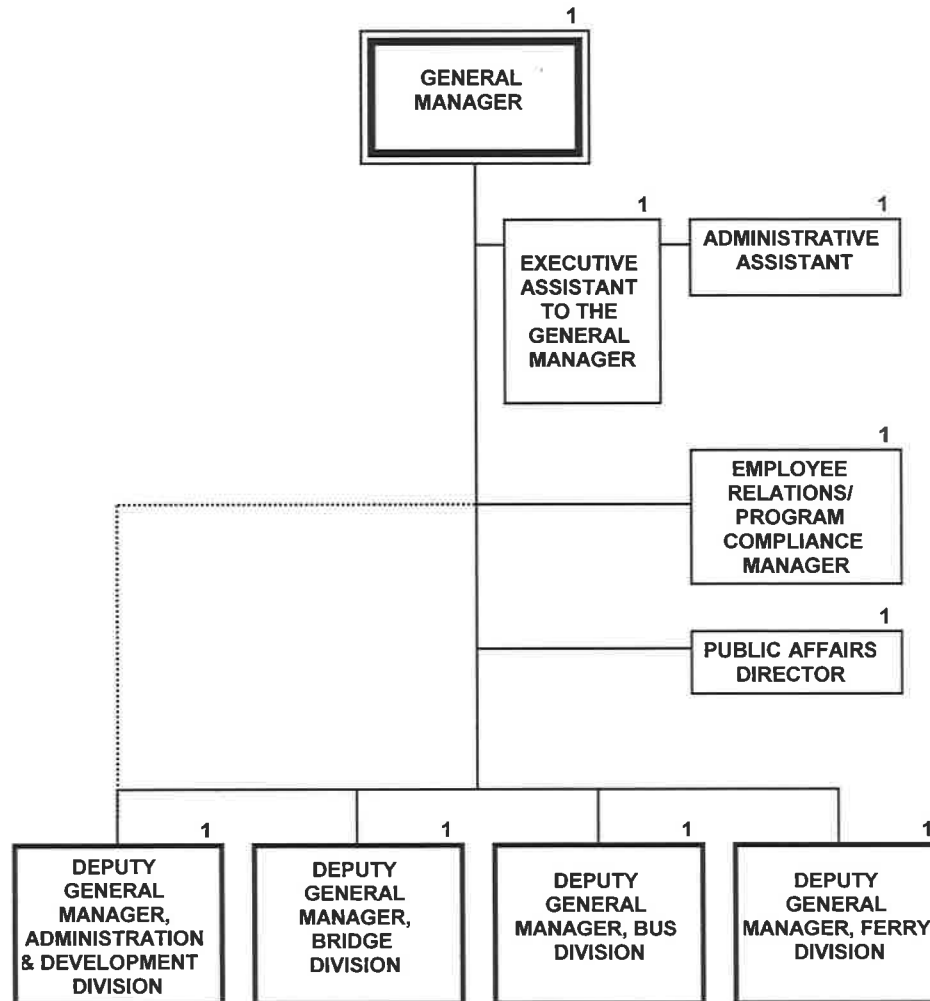

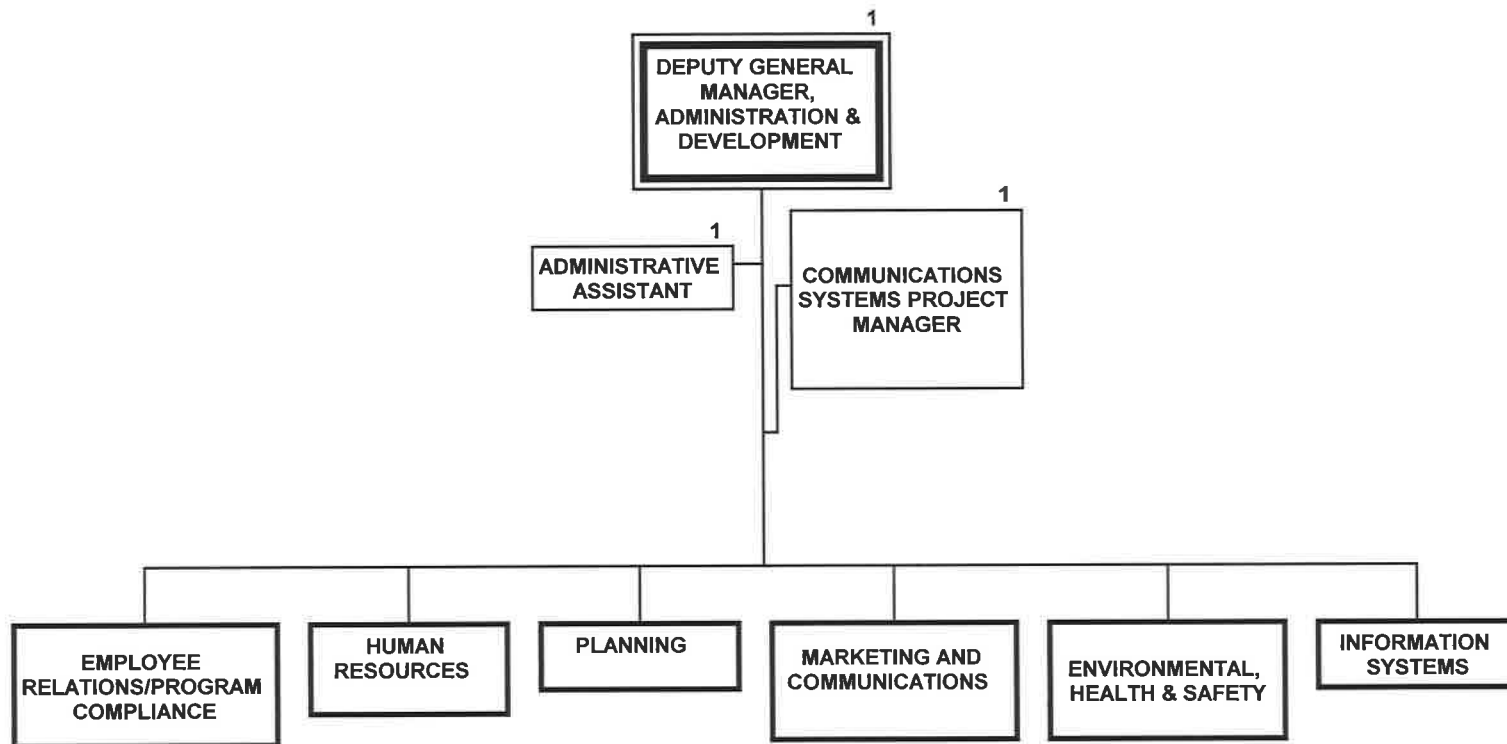
GOLDEN GATE BRIDGE BRIDGE, HIGHWAY AND TRANSPORTATION DISTRICT ORGANIZATION CHART



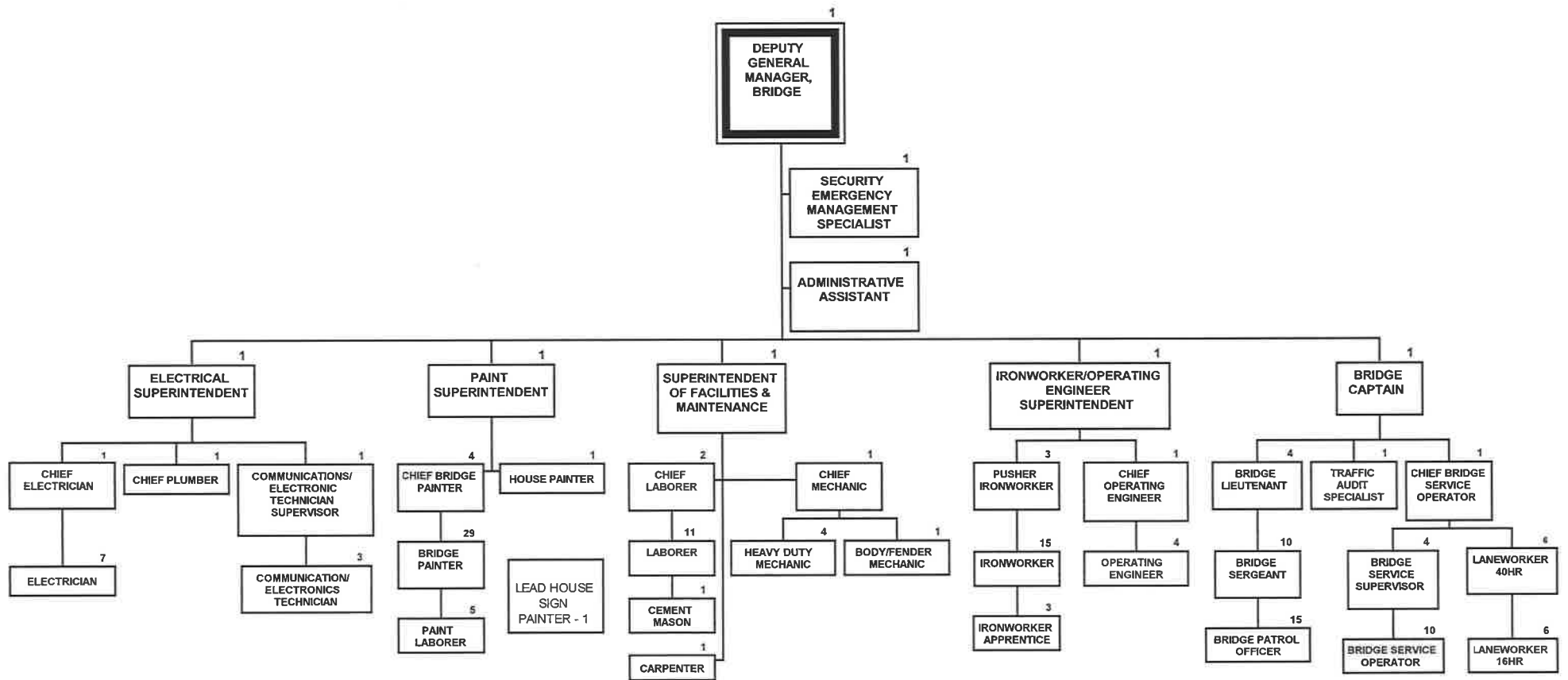

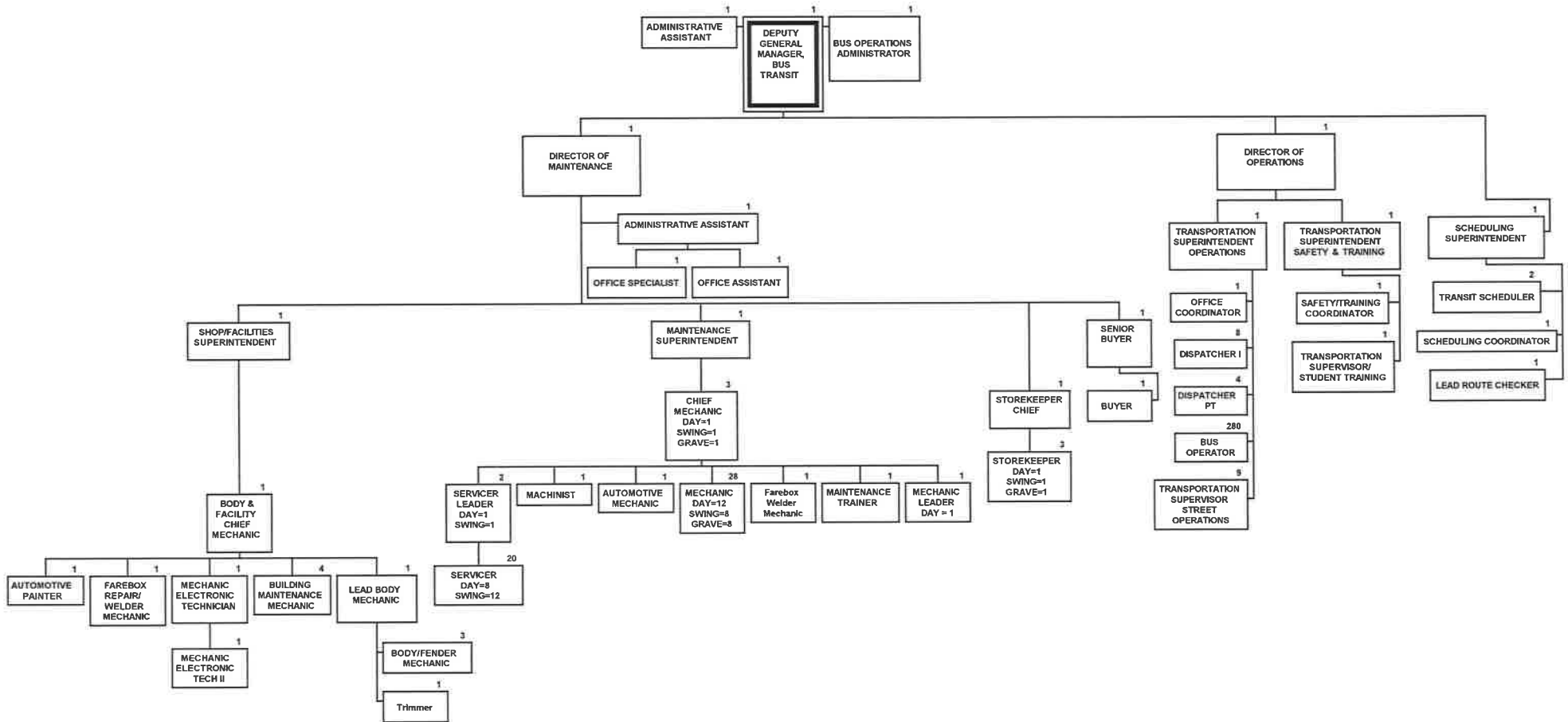

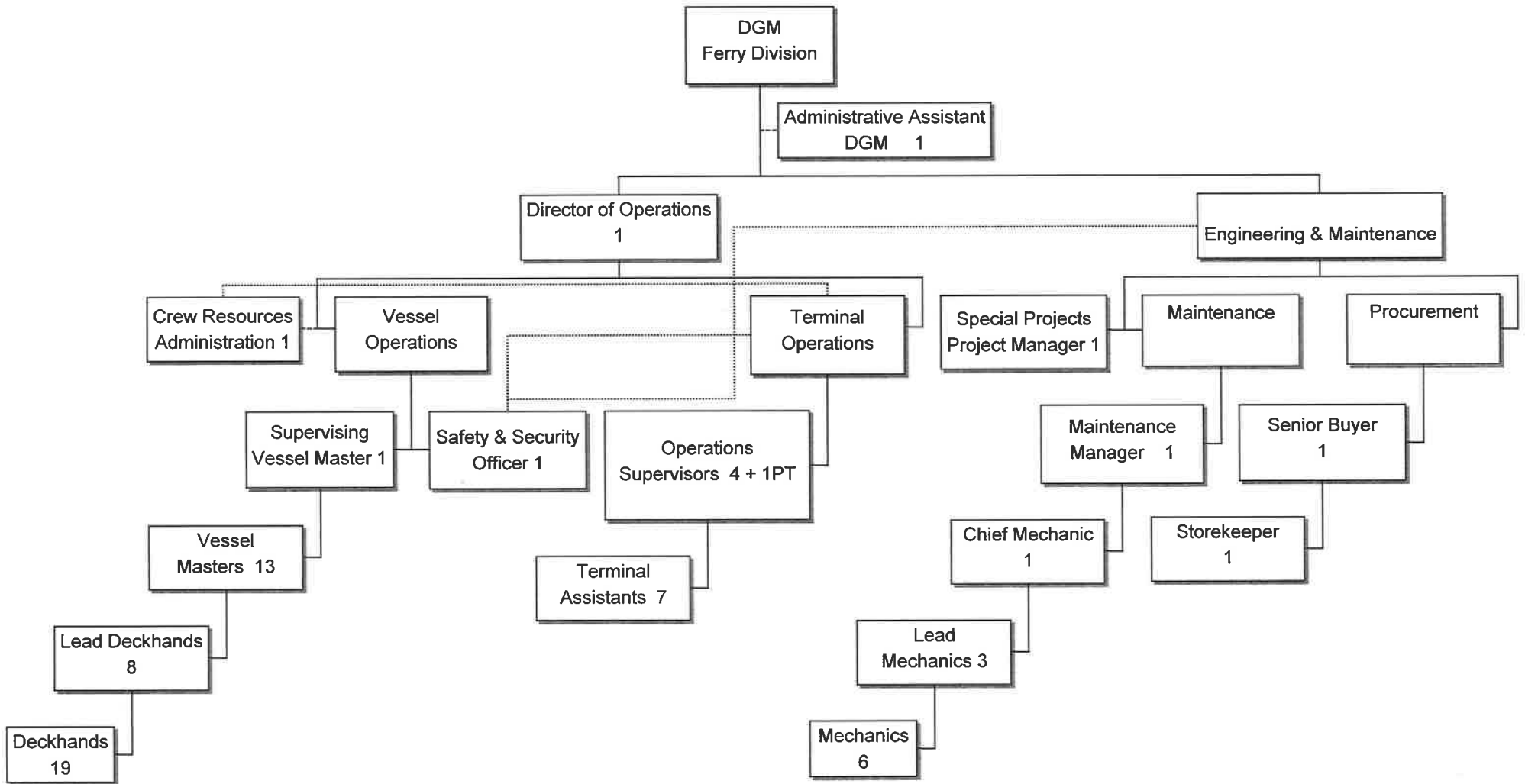
BRIDGE DIVISION



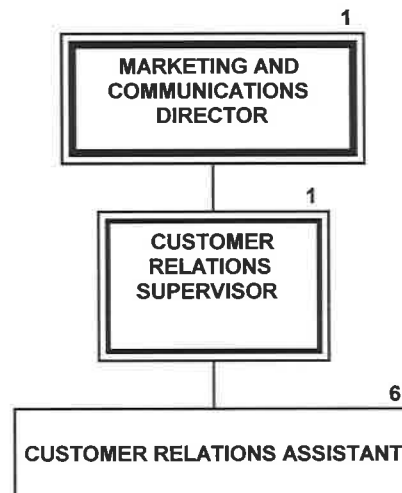
BUS DIVISION



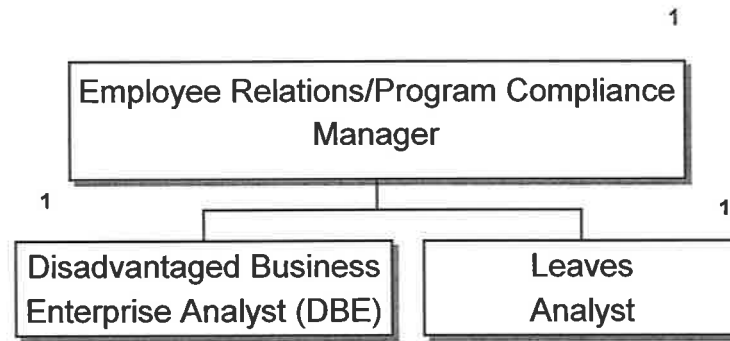
Ferry Division Organization Chart



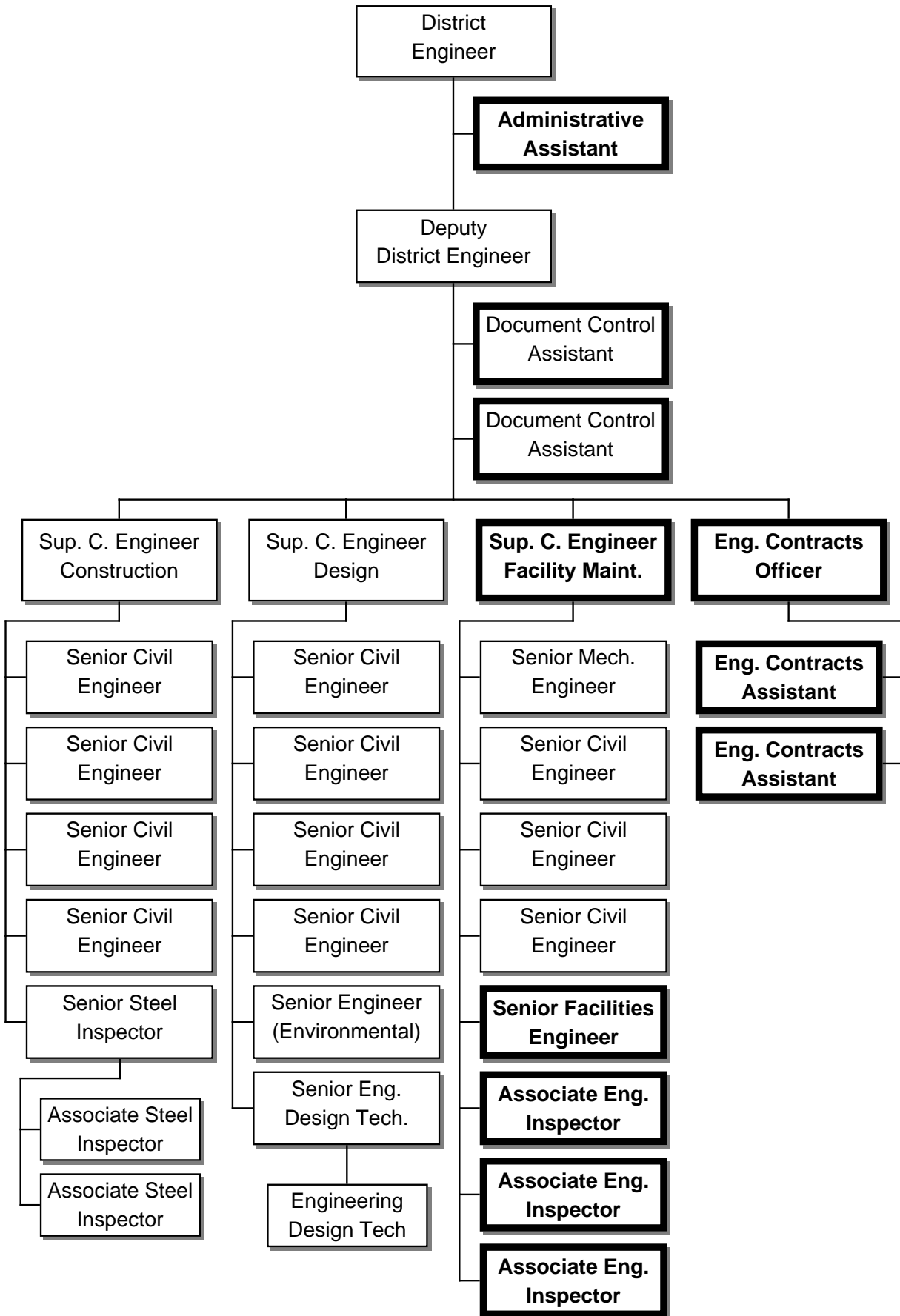

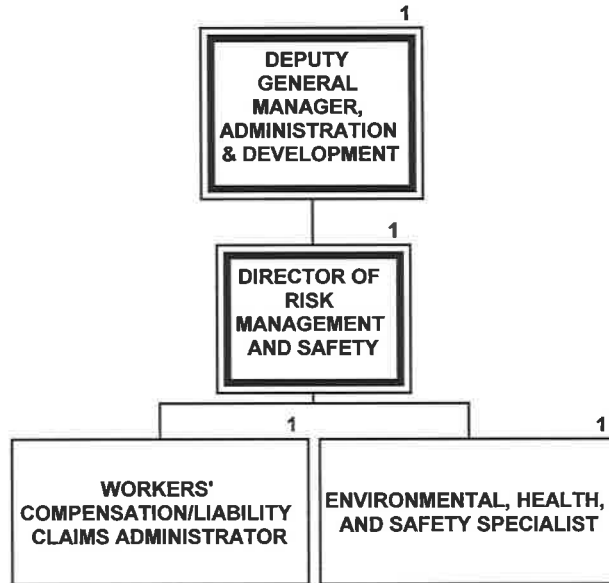
